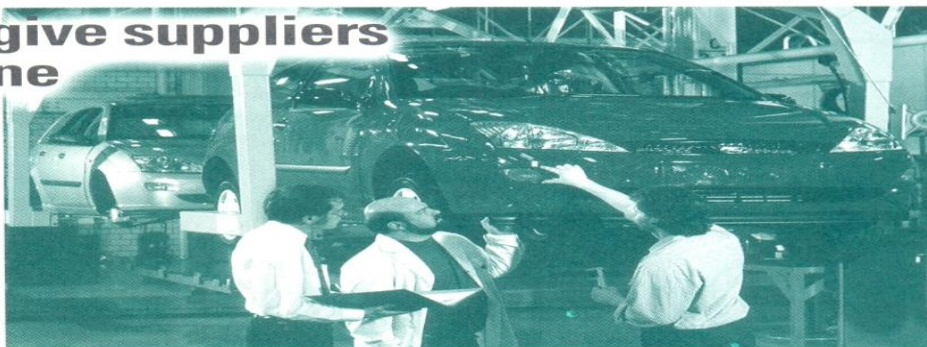

US auto makers give suppliers ISO 14001 deadline

The US automotive manufacturers General Motors (GM) and Ford have both announced deadlines for ISO 14001 implementation and certification by their suppliers. GM wants its suppliers to be operating ISO 14001-certified environmental management systems (EMS) by 31 December 2002, while Ford has announced a two-stage schedule with deadlines of 31 December 2001 and 1 July 2003.

ISO 9000 revisions move to Draft International Standard stage

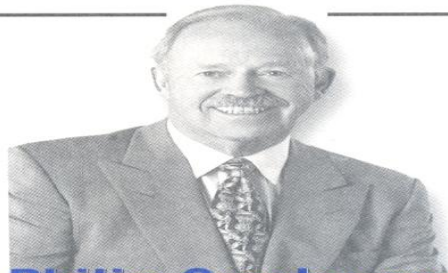

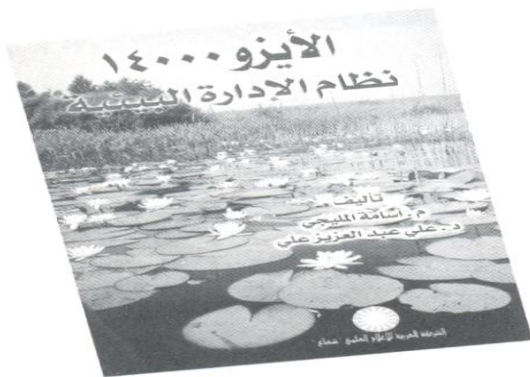

First Arabic book on ISO 14000

The first book in Arabic to deal with the ISO 14000 standards has sold more than 1 000 copies in Egypt, Saudi Arabia, Kuwait and other Gulf states since publication in April 1999.



The book is the work of Egyptian authors Eng. Osama El Meligy and Dr. Aly A. El Aziz who collaborate in the Total quality and environmental management consultancy¹⁾, of which Eng. El Meligy, an aeronautical engineer, is Chairman. Dr. El Aziz, a lead environmental auditor with a degree in food manufacturing, is an assistant professor at Ain Shams University, Cairo.

The book opens with an introduction to ISO, ISO 9000 and ISO 14000 and their importance in international trade. This is followed by:

- an overview of the ISO 14000 standards and the benefits of having an environmental management system (EMS);
- a discussion of the scope of an EMS with a glossary of related terms;
- an explanation of the elements of the EMS requirement standard, ISO 14001;

- a study of the principles and concepts behind ISO 14001, including a correlation with the Egyptian Environment Law 4-94;
- a guidance plan for implementation of an EMS, including training aspects, using the project management approach;
- environmental auditing.

There are also four annexes, including one giving a sample environmental manual of a food manufacturing company. Q

Implementing a quality system

How long will it take? Is the return on investment guaranteed? What does certification cost? How to diminish the costs of non-quality?

The above questions are typical ones occurring to the thousands of new organizations which each year weigh up the pro's and con's of embarking on the ISO 9000 journey. French and German speakers will find reasoned answers to such questions and many

more in the *Guide de la certification qualité*¹⁾ (Quality certification guide) available in those languages from the Swiss publisher J-M Blanc.

The guide is aimed both at organizations considering a quality programme and also at organizations which already achieved certification and wish to re-align their quality programme with their business objectives.

The publication, which comes in the form of an A4 ring binder, is designed to be user friendly thanks

to a clear structure, illustrations and practical examples. In the words of its publisher, it aims to achieve "useful excellence".

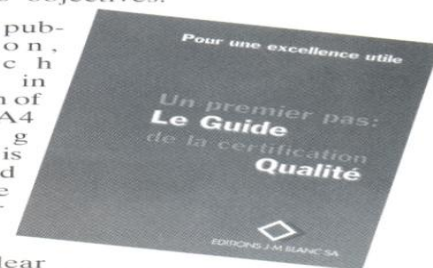
The core of the document concerns the setting up of a quality management system. This includes the key stages of a quality programme, as well as painting a picture of a process-oriented quality system. Examples given concern, amongst other features, electronic document control, a checklist for internal quality audits and a process for personnel management. The costs of quality and client satisfaction are underlined as essential items to be addressed in order to achieve useful excellence.

In addition, the reader will find a comparison of ISO 9000 and ISO 14000, and one of the ISO quality standard and the EFQM quality model.

The normal price of the guide is CHF 235 (USD 154). The publisher offers an annual update for an additional charge. Q
